



## SAVE THE DATE: IEEE 2016 ICCE-Berlin will be held 5-7 September, 2016.

Co-located with IFA and at IFA fair ground like previous editions

The IEEE International Conference on Consumer Electronics ICCE-Berlin is an excellent opportunity to spread your ideas and work in a scientific, technical and friendly environment (@IFA).

The way you can contribute to ICCE-Berlin is pretty flexible, follow the instructions:

### **Industrial Track (in all topics)**

It is a Track of special sessions for Industry papers (mainly targeted at companies in CE related industries). These sessions will feature 20 minute presentation slots for companies to make presentations on their technology and associated products and services. This track provides a unique opportunity to address an audience of consumer electronics OEMs and stakeholders.

These type of papers are usually of more practical contents and implementation focus. Papers submitted are subject to acceptance through the regular review by the technical program committee but qualified industry reviewers will do the review for these papers. In addition, papers submitted under this category can be excluded from IEEE Xplore if the authors want to retain their copyrights.

### **Instructions for authors - Industrial Track**

A contribution to ICCE-Berlin consists of a presentation. There is also a potential opportunity to contribute further in CE Society Journals or the Consumer Electronics Magazine:

- Industrial track is intended for presentation only. To be included in Xplore, the paper has to be submitted in R&D-Academic Track.
- These contributions will not be published in the postconference proceedings nor submitted to IEEEExplore but we require permission to post the details of the talk in the website. Moreover, we may request authors to provide a copy of the slides to be distributed in a USB during the conference.
- The contribution should be presented to the ICCE-Berlin audience.
- The board of industrial experts may encourage you to submit an extended version to the CE Society Journals.



## Contribution preparation - How to proceed?

1. **Prepare a 2 page extended abstract.** The submission does need to adhere to the standard IEEE format, and can be in format such as short abstract (minimum 500 words). Anyway it is very easy to format a 2 page text into the IEEE template (see <http://www.icce-berlin.org/2016/authors.html>), and provide if possible the speaker bio.
2. **Prepare any template-free material for evaluation.** An abstract may not be enough in some cases to determine the relevance with regard to the conference topics. Due to that, we encourage authors to upload any other material such as presentations or documents that can help the board of industrial experts to evaluate the work.

## Submitting

Once you have finished your contribution, go to EDAS <http://edas.info/N21929> and submit your contribution.

Be sure you select **Industrial Track** or **Industrial Contribution** when required.

You will be notified by email according to the **important dates** if your contribution is accepted or not and will receive further instructions.

### Contribution

#### R&D and academic tracks

This track is intended for **technical papers as tutorial, oral and poster presentation**. CE and papers reporting new developments in all areas of consumer electronics are invited. Read the **call for papers** for more information.

#### Industrial tracks

This track is meant for **contributions submitted by non-academic, mainly targeted at companies in CE related industries**. These types of contributions are usually of more practical contents. Submissions in this track are for presentation only, authors retain the copyright and their material will not be included in Xplore.

### Industrial tracks

The contribution will be reviewed by our board of Industrial Experts.

## Conference

### R&D and academic tracks

**Make an oral or poster presentation.**

Get feedback for improving your research, engage in interesting technical discussions, find potential contributions and make networking.

### Industrial tracks

**Make an oral presentation and optionally a demonstration during your talk .**

Get feedback for improving your work, engage in interesting technical discussions, find potential contributions and make networking



## Publication

### R&D and academic tracks

The accepted contributions will be submitted to be published in IEEEExplore and will be accessible to researchers all over the world.

### Industrial tracks

The contribution **will not be** included in the postconference proceedings neither **published in IEEEExplore**. Moreover, the **authors can retain their copyrights**.

## Other

### R&D and academic tracks

Authors are encouraged to contribute further to the Transactions on Consumer Electronics and any other CE society journal.

### Industrial tracks

Authors may be invited to contribute further to IEEE CE Society Journals or **Consumer Electronics Magazine –CE Mag**, by the board of industrial experts after or during the conference.
